## 18/1....APOLOGIES:

Councillor H. Ascroft's apology was received and accepted.

## 18/2....DECLARATIONS OF INTEREST:

## **18/3....MINUTES:**

The minutes of the December meeting where amended to show that Councillor Green had submitted his apology for absence, which was accepted.

It was resolved that the amended minutes of the meeting held on Monday 4<sup>th</sup> December 2017 were a true and accurate record and should be signed by the Chairperson.

## 18/4....ADJOURNMENT OF THE MEETING:

The meeting was adjourned at 7.35 pm.

One resident updated the Parish Council in relation to a boundary wall on Bescar Brow Lane, Scarisbrick. The issue has been reported to Lancashire County Council who have not visited the site. The wall requires rebuilding and a structural assessment. He understands that there is a structural element to the repair which is the responsibility of the Highways Department of the County Council. The builders approached by the resident to carry out repairs will not provide a quote for the work because of the structural work. It is the intention of the resident to discuss the matter with Councillor O'Toole.

## 18/7.....PROPOSED CINDER TRACK AT THE VILLAGE HALL

## 18/9... COUNCILLORS REPORTS AND ITEMS FOR FUTURE AGENDAS:

Councillor Holcroft reported on the Strategic Housing and Employment Land Availability Assessment meeting, attended by Councillor Herbert and Councillor Holcroft, on Monday 8<sup>th</sup> January 2018.

The assessment will include the need for affordable housing. Unlike the previous assessment this will be at Borough level not Parish level. The current priority given to Parish residents is under review. There are some concerns over the definitions used as rural employment does not include agricultural employment.

It was resolved that the February meeting will include the Strategic Housing and Employment Land Availability Assessment as an agenda item

Councillor Tinsley reported that the Bus shelter at Bullens Lane on the Ormskirk Boundary had been damaged over the Christmas period. The damage will be repaired.

Councillor Herbert and Councillor Marshall reported on the recent work undertaken by United Utilities at the junction of Turning Lane and Southport Road. The grassed verge had not been restored to its previous state. The issue of cars driving on the cycle path remains. Previously the County Council had agreed to install bollards to prevent this. The Clerk will make enquires and report in the next meeting.

The meeting concluded at 8.30pm.
