The bus shelter replacement programme was accelerated in 2019/20 with the help of a capital grant from West Lancashire Borough Council (see above). Expenditure on the programme during 2019/20 was £18,012. The difference in expenditure (£13,092) accounts for the year on year increase.

Asset values have always been recorded on the basis of original purchase price. Many of the Council's old stock of timber bus shelters were valued at a purchase cost much lower than the cost of the new replacements (some were over 30 years old). The total stock of bus shelters in 2018/19 was valued at £25,408. The stock in 2019/20 is now valued at £39,566 (including £1000 spent on upgrading some existing shelters). Our ageing stock of timber shelters has now been replaced by modern aluminium and Perspex equivalents. The value of the Council's bus shelter assets has therefore increased by £14,158 which accounts for the significant increase in the value of the Council's assets.
