24/007 PARISH COUNCIL NOTICEBOARDS (deferred from 4th December SPC Meeting):

There was a further discussion regarding the damage to the SPC noticeboard in the grounds of the Village Hall, and the locations and condition of other SPC noticeboards around the Parish.

It was noted that the Parish noticeboards located at Heaton's Bridge and Scarisbrick Marina are in poor condition,

It was resolved to:

Permit the Scarisbrick Village Hall to remove the damaged noticeboard and gift the metal posts to them for re-use.

Replace the Parish noticeboards located at Heatons Bridge and at Scarisbrick Marina – Clerk to obtain quotes for purchase and installation.
